# **Important Additional Information & Instructions**

## **Project Overview:**

Clemson University is seeking to engage a team of A/E professionals to design a stand-alone administrative building adjacent to the existing CUFD Fire Station 1 on Perimeter Road. The new building will provide office space for CUFD leadership (Chief and Deputy Chief) and administrative staff including Fire Marshall, Fire Inspectors, Training Coordinator and other administrative positions. The new facility will also provide a multi-purpose room for training, a conference room, equipment storage, and new waiting room and lobby for visitors/public away from the operations side of the fire station.

Along with the new administrative building, the project includes renovations to the existing fire station. Construction of the new office and support space will allow for temporary offices in the fire station to be returned to use as bunkrooms for firefighters. Renovations in the existing fire station include building systems updates and interior finishes. Renovations include extension of interior partitions for better acoustic privacy in the bunkrooms, new flooring, ceilings, and paint throughout the building, and replacement of kitchen casework and counters.

In accordance with the South Carolina Green Purchasing Initiative, submittals cannot exceed 20 double-sided pages. The Standard Federal Form 330 is not included in this page count. The electronic file must be in PDF format and be a single file no larger than 10 MB.
